# Events that have been described by media as crimes of ecocide

- Russia is believed to have blown up the Kahovka dam in the Dniepr river in Ukraine on 6th June, 2023
- Unidentified operator blew up the Nord Stream gas pipelines in the Baltic Sea on 26th September, 2022
- Destruction of marine environments by bottom trawling and industrial fisheries
- Enormous oil spills in oceans
- Chemical accidents and weapons

# Ecocide

- Biologist Arthur Galston introduced the concept in 1970 (based on bombing in Vietnam and Laos with Agent Orange)
- Olof Palme, Prime Minister of Sweden at the Stockholm environmental conference 1972
- Prof. Richard Falk (Univ of Princeton) 1973 draft proposal for an international law on ecocide as a crime to the UN International Law Commission, not discussed nor agreed upon
- 2017 Stop Ecocide Foundation established
- 2023 Euroopean Parliament proposed to include ecocide in the revised EU directive on Environmental Crime



1. In August 2020 activists Raila Knuuttila and Mikko Husman co-founded Ecocide Law Finland together with Stop Ecocide International to serve the purpose of having a campaign team in Finland. The launching event with Jojo Mehta was held in a webinar in November 2020.

2. Marko Ulvila (Siemenpuu Foundation) proposed in September 2020 to collect signatures for an appeal to the Government of Finland to support making ecocide a crime in international law.

At last year's ASP in The Hague, small island States Parties to the ICC Vanuatu and Maldives addressed the need for ecocide to be seriously considered by the ICC. Support has been expressed at state level by France and Belgium, with parliamentarians in a growing number of countries now discussing this legal route to sanctioning the worst excesses of environmental damage. The event will cover key legal, historical and political considerations as well as examining the broader implications of this approach to protecting Earth's crucial lifesupport systems.

### Youth Alliance of Finland hopes that Governments of Finland and other Nordic countries would give support

At the Stockholm+50 Climate Conference in 2022 the Nordic youth expressed their wish that the Nordic Council of Ministers would discuss criminalization of ecocide. Paula Lehtomäki, Secretary General of the Council, promised that there will be such discussion.

The matter is on the agenda of the Council, but no decision has been reached.

# The definition proposed by the panel in June 2021

Pconde

"ecocide" means unlawful or wanton acts committed with knowledge that there is a substantial likelihood of severe and either widespread or long-term damage to the environment being caused by those acts.

# Note about the panel

- The panel of experts was established by the Stop Ecocide Foundation in 2020
- The paneel was proposed by Members of the Parliament of Sweden (parties in the government)
- Co-chair Philippe Sands QC, expert on environmental and human rights law, especially the Nurenberg Tribunal of 1948
- Other Co-chair is Dior Fall Sow (Senegal)

# Note about the definition

- Not retroactive
- If too comprehensive, might not be accepted by governments
- If too mild, would not have teeth
- All ecological spheres of the Earth are targeted
- Expressions and concepts are taken from existing international law
- The definition does not list typical crimes, indictments are confirmed and handled by a panel of three Judges of the ICC

- Significant preventive impact also in the business world
- Inhibits unfair and destructive competition
- Possibility to foresee consequences of one's own actions
- The Financial Times: projects potentially harmful to the environment could face difficulties in getting financing, guarantees, insurances and permits

# Making ecocide a crime received international support

- Governments: Vanuatu, The Maldives, Belgium, Samoa, Bangladesh, Bolivia, Kenya, Liechtenstein
- European Parliament statements 2021, 2023
- Council of bishops of Sweden supported in September 2021
- Encouragement to governments to discuss ecocide by Executive Vicepresident of the European Commission Frans Timmermans 2021
- International Corporate Governance Network support for ecocide law 2021, 2022

- **Pope Francis** supported criminalization in XI 2019, 2022
- **President Macron of France** supported the international aspiration June 2020
- Ortodox Ecumenical Patriarch Bartholomew international law to consider ecocide October 2021
- UNSG Antonio Guterres wished for criminalization 3rd July 2021
- Inger Andersen, Executive Director of UNEP 5th June 2022 word ecocide will eventually get into UN vocabulary
- International Parliamentary
   Union support for criminalization

# The way forward

**Conference of the States Parties to ICC December 2023 in The Hague conversation to continue at least informally** 

To be debated if half of the States Members (62) support it. Approval when 2/3 of them support (82). Small island states have an important share of the votes.

Civil society / Global Major Groups opinion increasing weight – UN Youth Task Force, also Avaaz, SumOfUs/Eko, Parliamentary Union of the Council of Europe

Targets circular economy, carbon binding farming, ban on polluting plastics, driving down fossile energy

- A separate agreement on ecocide would not work out because consensus would not be agreeable to USA, Russia, China, Saudi Arabia, Iran, Israel
- Can the Nordic Countries agree?
- Brasilian president Lula da Silva has difficulties in fulfilling his good promises.
- Can China's promise of carbon neutrality have impact on China's imports from Brazil?
